

Miss Autumn of Carbondale Pageant

Rules and Eligibility

I hereby apply as an entrant in the Miss Autumn of Carbondale Pageant and I acknowledge and agree to all the rules and regulations as follows:

1. I will be at least eighteen and not more than 25 years of age on November 6, 2011.
2. I am of good health and moral character.
3. I agree to the following dress code: Participants will wear a dress, suit or skirt and blouse for Interview Competition, Fashion Wear Competition, a full length gown for the Evening Gown Competition and a solid, one-piece swimsuit for the Swimsuit Competition. No exposing midriff tops, tattoos, exposed piercing shall be limited to ears only. No outlandish hair color such as purple, blue, etc.
4. I agree that if I am selected as Miss Autumn of Carbondale, I will be available December 3, 2011, and two dates to be determined in May and October 2012, for the Downtown Art and Wine Fairs. I also agree that I will represent Carbondale Main Street at various events and other festival parades throughout Southern Illinois. I also agree to participate in the 2012 Miss Autumn of Carbondale as retiring queen and to crown the new Miss Autumn of Carbondale.
5. I agree that if selected as Miss Autumn of Carbondale, that I will furnish a driver of at least 21 years of age, with a valid driver's license and proof of insurance to drive me in optional events which might require a rented or loaned vehicle. I also agree that if myself or my driver causes damage to any said rented or loaned vehicle while representing the Carbondale Main Street Committee, I shall hold harmless said committee from any and all liability to said vehicle or any damage I may cause to another vehicle or individual.
6. I agree that I win or succeed the winner of the Miss Autumn of Carbondale Pageant, I will not participate in any inappropriate pageant or contests during the time I hold this title. The committee has no objection to you entering a legitimate pageant. Example of an inappropriate event would be using your title of Miss Autumn of Carbondale and competing in a "Wet T Shirt Contest"

I hereby release unconditionally and forever, any claim against the Carbondale Main Street Committee, or it's officers, directors, employee, agents, subsidiaries, assigns, or corporate parents, which I may have by virtue of my participation in this pageant or any of the use of my name, likeness, voice and/or biography in connection with this pageant, including; but not limited to use in promotional or advertising material.
8. I understand and agree that the Carbondale Main Street Committee, Miss Autumn of Carbondale determine as to eligibility, and I agree to abide by said determination both as to myself and the other applicants. Any untrue statement or failure to comply may result in applicant's disqualification.
